**Obvious things that move a car to Group-3 include:** Non-stock cam, heads, throttle body/carb, intake manifold, Oversize brake rotors, non-stock calipers, non-DOT tires, Non-stock Blower or Turbo, etc. \*\*Coil-overs = Grp 3  
 \*\*Weight reductions = RP \*\*Up/backdate between Year Groups (exc C2/C3) = RPAF
