Vendors must be set up by 8:30 am.

All Vendor vehicles must be moved to the designated area by 8:30 am.

Vendor's vehicles may be driven and parked in designated areas only.

Vendors must have a representative at their booths at all times during show hours.

Vendors will take full responsibility of any damages to participant's property or guests property caused by high winds, storms or other acts by the vendor where vendor's tents, goods or violent actions by the vendor or a vendor's representative or employee brings harm or damage to show participants or guest of the show.

Vendors must adequately anchor their tents. A minimum weight of 24 pounds per tent leg is recommended. If your tent is not anchored, you will be asked to leave and no refund will be given.

The show organizers will not be responsible or liable for any damage to vendor's property.

Vendors are not permitted to sell alcohol, weapons, explosive property or material deemed to contain pornographic content.

Alcohol is not permitted within the vendor or car show areas

Vendors are not permitted to run generators.

Payment may be mailed prior to the show date or paid on the day of the show.
